PLEASE READ THE FOLLOWING CAREFULLY AND SIGN BELOW:

1. The overnight permit covers the hours from 6:00 p.m. to 8:00 a.m. After 8:00 a.m. (Monday – Saturday), I understand that my vehicle must be removed by 8:00 a.m. or moved to a proper lot and that I am responsible for the daytime parking fees except for #2 below.
2. If you are parked (Monday – Friday only) in the Maple Street, Tier Garage or Post Office Lots and you are not a “Downtown Employee”, your vehicle must be removed from the lot or you will be ticketed. These are “Employee Only” daytime parking lots.
3. The OVERNIGHT PERMIT should be placed on the inside of the REAR windshield, lower right hand corner of the passenger side (see diagram on back of permit).
4. Only one overnight permit is to be displayed at one time.
5. Each new quarterly permit shall be displayed as of 12:01 a.m. on the first day of the quarter (Example: Quarter starts January 1, 2006, the permit needs to be in your vehicle on December 31, 2005).
6. The City of Summit is not responsible for lost or stolen permits.
7. Weather Restrictions:
  - a. In the event of a snowfall prediction, I agree to park in the BROAD STREET PARKING GARAGE or TIER GARAGE so as to allow for proper snowplowing of the overnight lots.
  - b. I understand that the City of Summit is not responsible if I do not move my vehicle to the Broad Street Garage or Tier Garage and the vehicle gets plowed in.
  - c. As stated in Section #1 above, I understand that I must move the vehicle from the Broad Street Garage before 8:00 a.m. on each day.
8. If I purchase the next quarterly permit after the first day of the quarter, I understand that I am still responsible for the full quarterly payment of \$75.00 (\$56.25-seniors).
9. If I no longer require the permit within a current quarter, I may return the permit to the City for the appropriate pro-rated refund.
10. I have read and understand the above regulations concerning overnight parking and understand that if they are not adhered to, I would be subject to appropriate penalties including loss of the permit.
